WHO'S ELIGIBLE TO APPLY?

All undergraduate students enrolled or to be enrolled in an HEC accredited University or Degree Awarding Institute (DAE)

WHAT ARE THE SCHOLARSHIP DETAILS?

Amount: Semester Fee for 8 semesters.

Deadline: October 1, 2021

Awarded: October 30, 2021

Candidate should score minimum 3.0 GPA in each semester continue to receive the scholarship.

HOW TO APPLY

- Provide proof of enrollment in an HEC accredited Institute or university, a transcript, tuition receipt, or acceptance letter will be accepted.
- Kindly complete the application form and submit it with relevant attested documents.

APPLICATION DEADLINE?

All applications must be submitted by Friday October 1st, 2021 (closes at Midnight, Pakistan Time) through email or online. The winner will be selected and notified via email.

ADDITIONAL SCHOLARSHIP DETAILS:

1. Winning candidate will be selected by a panel of 5 members
2. The scholarship is available on semester basis and is renewable subject to satisfactory performance (minimum 3.0 GPA in each semester) till the completion of the degree program.
3. Scholarship funds will be sent by cross check to the Institute or University. Funds are to be applied to qualified semester Fee for the current academic year

SCHOLARSHIP AWARD RULES

Subject in each case to the terms and conditions set forth in these Rules (“Rules”), BIPP will award one scholarship each year in the amount of semester Fee applicable by the Institute or University (timed to coincide with the beginning of a typical Institute/University Fall semester 2021).

ELIGIBILITY

Legal residents of Pakistan who are eighteen years of age or older at the time of applying and who are currently enrolled in an HEC accredited Institute or University are eligible to apply for the scholarship.

Void where prohibited by law.

Do not submit an application if you do not agree to the terms and conditions of these Rules.

HOW TO APPLY FOR THE SCHOLARSHIP

Applicants will submit contact information (name, email, etc.) and upload their attested scanned documents through our scholarship form

Limit of one application per person.

All applications, including all content, become the property of BIPP and will not be returned. The content included in applications may be used in marketing materials or posted on the BIPP website without further compensation or notice to the applicant. In no event shall BIPP be liable for any potential recipient notification that is lost, intercepted, or not received for any reason.

By submitting an application, you fully and unconditionally accept and agree to these Rules and the decisions of BIPP, which are final and binding.

PROCESS OF SELECTION FOR POTENTIAL SCHOLARSHIP WINNERS

BIPP is seeking eligible applicants who can clearly and concisely address the topic in a creative way. BIPP will select one potential winner based on the criteria of creativity, ability, originality, and applicability of any content submitted. A committee constituted by BIPP will select potential recipients. The potential winner will be obligated to supply proof of enrollment in the Institute or university indicated in the application before any award is given. The potential winner will be notified via private message through social media or email. BIPP will not be liable for any potential recipient notification that is lost, intercepted, or not received by the potential recipient for any reason.

PAYMENT OF SCHOLARSHIP AWARD

The selected winner will receive a Scholarship Award in the amount of Semester Fee payable through crossed Cheque directly to HEC accredited Institute or University where he or she is enrolled, once the Scholarship Awarded Recipient has enrolled and submitted proof of enrollment to BIPP.

Awarded Recipient must submit proof of enrollment for the current semester. Scholarship Awards may not be assigned, transferred, or changed, except at the sole discretion of BIPP.

No cash equivalent Scholarship Awards will be awarded.

The awarding of any Scholarship Award is contingent upon full compliance with these Rules. Applicants agree to be bound by Rules and agree that if any Scholarship Awarded Recipient fails to respond to electronic communication within ten (10) calendar days, provide proof of identity, refuses to provide required affidavit, refuses to complete and provide any requested information, is found to have violated the Rules, or does not meet eligibility criteria, Scholarship

Award will be forfeited and the Applicant who submitted the Application with the next highest score will become an alternate potential Scholarship Awarded Recipient.

Applicants understand that BIPP is not liable for injuries, losses, or damages of any kind arising from participation in this Scholarship Program and acceptance, possession, and use of Scholarship Award.

BIPP is not responsible for any typographical or other error in the printing of the offer, administration of the Scholarship Program, or in the announcement of the Scholarship Award.

PRIVACY

By submitting an Application, you acknowledge that BIPP and its related units may contact you in relation to the scholarship.

PUBLICITY

Except where prohibited by law, by accepting a scholarship award from BIPP, the recipient agrees that BIPP may, without any limitation or further compensation or notice, use his or her name, voice, and/or likeness in any and all media, worldwide, for the purpose of advertising and promoting BIPP mandate and/or its services, or the Scholarship program. FURTHER DOCUMENTATION

Except where prohibited, potential Scholarship Awarded Recipients (or their parents or legal guardians if they are minors at the time of application) will be required to complete and return an Affidavit of Eligibility and compliance of Rules within ten (10) days of notification or the Applicant with the Application with the next highest score will become an alternate potential Scholarship Award Recipient. If notification to a potential Scholarship Award Recipient is returned as undeliverable, the Applicant with the Application with the next highest score may become an alternate potential Scholarship Award Recipient

Website, to be acting in violation of these Rules, to be submitting responses dishonestly or inaccurately, or to be acting in an unsportsmanlike or disruptive manner. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. The authorized account holder is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. If an Application is confirmed by BIPP to have been erroneously deleted, lost, or destroyed, the entrant's sole remedy shall be another Application, if time permits.
